### **4. APPROVAL OF MINUTES FROM APRIL 17, 2013 MEETING**

**A motion was made by Mr. Miller, seconded by Mr. Brady and approved by majority vote to approve the minutes of the April 17, 2013 meeting, with Mr. Greenspan recusing himself from the vote due to his absence from the meeting.**

## 5. MATTERS REFERRED TO COMMITTEE

- a) R2013-0084: A Resolution making an award on RQ27305 to Emerald Development and Economic Network, Inc. in the amount not-to-exceed \$10,248,516.00 for administration of the Shelter Plus Care Tenant-based Rental Assistance Program in connection with the McKinney-Vento Homeless Assistance Act for the period 4/10/2013 - 4/9/2014; authorizing the County Executive to execute the contract and all other documents consistent with said award and this Resolution; and declaring the necessity that this Resolution become immediately effective.

**Ms. Ruth Gillett, Manager, Office of Homeless Services; and Ms. Elaine Gimmel, Chief Operating Officer, Emerald Development and Economic Network, Inc. (EDEN); addressed the Committee regarding Resolution No. R2013-0084. Discussion ensued.**

**Committee members asked questions of Ms. Gillett and Ms. Gimmel pertaining to the item, which they answered accordingly.**

**On a motion by Mr. Miller with a second by Mr. Jones, Resolution No. R2013-0084 was considered and approved by unanimous vote to be referred to the full Council agenda with a recommendation for passage under second reading suspension of rules.**

- b) R2013-0085: A Resolution making an award on RQ26276 to Youth Opportunities Unlimited in the amount of \$4,819,176.00 for the Temporary Assistance to Needy Families Summer Youth Employment Program for the period 5/15/2013 - 8/31/2013; authorizing the County Executive to execute the contract and all other documents consistent with said award and this Resolution; and declaring the necessity that this Resolution become immediately effective.

**Mr. Joseph Gauntner, Director of Job and Family Services; and Mr. Craig Dorn, Vice President, Youth Opportunities Unlimited; addressed the Committee regarding Resolution No. R2013-0085. Discussion ensued.**

**Committee members asked questions of Mr. Gauntner and Mr. Dorn pertaining to the item, which they answered accordingly.**

**On a motion by Mr. Brady with a second by Mr. Miller, Resolution No. R2013-0085 was considered and approved by unanimous vote to be referred to the full Council agenda with a recommendation for passage under second reading suspension of rules.
