**II – REVIEW MINUTES – 6/13/2022**

Leigh Tucker motioned to approve the minutes from the June 13, 2022 meeting; Dale Miller seconded. The minutes were approved by unanimous vote, as written.

Matt Rymer, Department of Public Works, presented. There were no questions. Leigh Tucker motioned to approve the item; James Boyle seconded. Item BC2022-370 was approved by unanimous vote.

Matt Rymer, Department of Public Works, presented. There were no questions. Leigh Tucker motioned to approve the item; Dale Miller seconded. Item BC2022-371 was approved by unanimous vote.

Tom Pavich, Department of Public Works, presented. Dale Miller commented on the millions of dollars the County spends on software licenses and asked if there was any thought to coordinate software purchases with Department of Information Technology, to prioritize purchases and possibly achieve cost savings; said licensing purchases need coordination and a systematic approach in this large operation, where a lot of money is spent for these services; and said the Department of Information Technology needs to work with various departments to get a handle on overall activity for license purchases to reap potential savings. Leigh Tucker motioned to approve the item; Dale Miller seconded. Item BC2022-372 was approved by unanimous vote.

Mike Zapola, Fiscal Department, presented. James Boyle commented that while the Ohio Revised Code requires print advertisement for these notices, that these could be advertised in a more contemporary fashion and hopes this process will eventually be modernized. Leigh Tucker motioned to approve the item; James Boyle seconded. Item BC2022-373 was approved by unanimous vote.

Dennis Sullivan and Jeremy Mio, Department of Information Technology, presented. Nan Baker asked for clarification on what the overall price for all phases of this project will be; asked how this project interacts with Enterprise Resource Planning System; asked if future purchases related to this long-term project will go to Board of Control or Council Committee for further discussions on goals and costs; said the anticipated amounts for future phases seem high for Board of Control consideration; and asked what form of protection is in place currently. Dale Miller asked if this is considered a Disaster Recovery Project or is the scope broader; asked what the name of the project was, its' overall purpose and total estimated cost; asked if the purpose is to protect the County from critical failures; said that a general information session for Finance and Budgeting Committee may be necessary. Ms. Baker concurred with Mr. Miller's recommendation for Committee discussion. James Boyle asked for more information on Nexum, Inc.; asked if there will be 3-4 more phases for the project; asked if Nexum, Inc. will be involved in those phases; said that using an RFP exemption to select this provider because they have familiarity with the project and has done good work in the past is problematic because it gives them a leg up on the competition for future phases of the project; said that use of RFP exemptions should be the exception rather than the rule because this may start as a \$14,000.00 purchase but could potentially be much larger as the project evolves; said there may be a different discussion if this was a State contract; and asked for clarification on the funding source. Paul Porter said that future hardware purchases related to this project may not require an RFP exemption; said that having a provider with familiarity of the architecture of the existing data center can give the County an advantage rather than someone who needs to learn about our disaster recovery infrastructure; and said that this may not have been competitive had it been bid, due to the low amount. Mr. Boyle concurred with Mr. Porter's comments but restated his concern for the continuation of using bidders in the County employ, rather than open to competition. Leigh Tucker motioned to approve the item; Dale Miller seconded. Item BC2022-374 was approved by unanimous vote.

James Boyle asked if this request has any bearing or relationship to the Diversion Center. Leigh Tucker motioned to approve the item; Dale Miller seconded.
