Sponsored by: County Executive FitzGerald/County Engineer	A Resolution making an award on RQ18544 and authorizing the County Executive to enter into a contract with Liberta Construction Company in the amount not-to-exceed \$4,837,941.50 for the repair and resurfacing of Sprague Road from York Road to State Road in the cities of North Royalton and Parma; declaring the necessity that this Resolution become immediately effective.

WHEREAS, the repair and resurfacing of Sprague Road from York Road to State Road in the cities of North Royalton and Parma has been found to be in the best interests of the health, safety and welfare of the citizens of Cuyahoga County; and

WHEREAS, the County Engineer reported that its office received bids on November 16, 2010, tabulated the extension of prices submitted by each bidder and verified the accuracy of the total amounts; and

WHEREAS, the Office of the County Engineer found Liberta Construction Company to be the lowest qualified bidder and that Liberta submitted all necessary documents per the proposal, plans and specifications; and

WHEREAS, it is necessary that this Resolution become immediately effective in order that critical services provided by Cuyahoga County can continue and to provide for the usual, daily operation of a County department;

NOW, THEREFORE, BE IT RESOLVED BY THE COUNTY COUNCIL OF CUYAHOGA COUNTY, OHIO:

SECTION 1. That the County Executive is authorized to enter into a contract with Liberta Construction Company (RQ18544) in the amount not-to-exceed \$4,837,941.50 for the repair and resurfacing of Sprague Road from York Road to State Road in the cities of North Royalton and Parma.

SECTION 2. Funds have been certified and encumbered sufficient to fund this contract.

SECTION 3. It is necessary that this Resolution become immediately effective in order that critical services provided by Cuyahoga County can continue, and to continue the usual and daily operation of the County. Provided that this Resolution

receives the affirmative vote of eight members elected to Council, this Resolution shall become immediately effective upon the signature of the County Executive.


