Sponsored by: County Executive FitzGerald/Office of Early Childhood	A Resolution authorizing the County Executive to enter into a contract with Starting Point in the amount not-to-exceed \$2,038,762.00 for management and administration of the Family Child Care Home Regional System for the Invest in Children Program for the period 1/1/2011 - 12/31/2011, and declaring the necessity that this Resolution become immediately effective.

WHEREAS, Cuyahoga County's Office of Early Childhood desires to enter into contracts with Starting Point for the management and administration of the Family Child Care Home Regional System for the Invest in Children Program for the period of January 1, 2011 through December 31, 2011; and

WHEREAS, the primary goals of the Family Child Care Home Regional System are to increase access to care and improve the quality of care provided in family child care homes; and

WHEREAS, Starting Point, as the child care resource and referral agency for Cuyahoga County, is designated as the System Coordinator for this core component of the Invest in Children Program; and

WHEREAS, it is necessary that this resolution become immediately effective in order that critical services provided by Cuyahoga County can continue and to provide for the usual, daily operation of a County department;

NOW, THEREFORE, BE IT RESOLVED BY THE COUNTY COUNCIL OF CUYAHOGA COUNTY, OHIO:

SECTION 1. That the County Executive is hereby authorized to enter into a contract with Starting Point for the Office of Early Childhood for services necessary to operate the Invest in Children Program, not to exceed \$2,038,762.00 for the period of January 1, 2011 through December 31, 2011.

SECTION 2. Funds have been certified and encumbered sufficient to fund this contract.

SECTION 3. It is necessary that this Resolution become immediately effective in order that critical services provided by Cuyahoga County can continue, and to continue the usual and daily operation of the County. Provided that this Resolution

receives the affirmative vote of eight members elected to Council, this Resolution shall become immediately effective upon the signature of the County Executive.

SECTION 4. It is found and determined that all formal actions of this Council relating to the adoption of this Resolution were adopted in an open meeting of the Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
