WHEREAS, Cuyahoga County, through its Department of Children and Family Services, entered into contracts with various providers for the Family to Family Neighborhood System of Care for the period January 1, 2010 through December 31, 2011; and

WHEREAS, the County desires to amend those contracts by adding additional funds to each contract in the amount of \$320,464.00; and

WHEREAS, it is necessary that this resolution become immediately effective in order that critical services provided by Cuyahoga County can continue and to provide for the usual, daily operation of a County department;

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF CUYAHOGA COUNTY, OHIO:
