

# County Council of Cuyahoga County, Ohio

## Resolution No. R2011-0122

Sponsored by: **County Executive FitzGerald/Department of Public Works/County Engineer**

**A Resolution** making an award on RQ19284 and authorizing the County Executive to enter into a contract with Great Lakes Construction Co. in the amount of \$4,954,904.03 for construction of a grade separation on Fitch Road over the Norfolk Southern Railroad in the City of Olmsted Falls and Olmsted Township, and declaring the necessity that this Resolution become immediately effective.

WHEREAS, the County Engineer has recommended an award to Great Lakes Construction Co., in the amount of \$4,954,904.03 for the construction of a grade separation on Fitch Road over the Norfolk Southern Railroad in the City of Olmsted Falls and Olmsted Township; and

WHEREAS, this award recommendation is based upon the finding that Great Lakes Construction Co., is a qualified bidder at the lowest cost to the County; and

WHEREAS, it is necessary that this Resolution become immediately effective to assure construction can start May 1, 2011 and be completed by June 1, 2013 per plan specifications. In addition, this timeframe marks the prime construction season and any delay could incur additional expenses to the County.

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNTY COUNCIL OF CUYAHOGA COUNTY, OHIO:**

**SECTION 1.** That the County Council hereby authorizes the County Executive to award RQ19284 and to enter into a contract with Great Lakes Construction Co., in the amount of \$4,954,904.03 for the construction of a grade separation on Fitch Road over the Norfolk Southern Railroad in the City of Olmsted Falls and Olmsted Township.

**SECTION 2.** It is necessary that this Resolution become immediately effective to assure construction can start May 1, 2011 and be completed by June 1, 2011 per plan specifications. In addition, this timeframe marks the prime construction season and any delay could incur additional expenses to the County. Provided that this Resolution receive the affirmative vote of eight members of Council, this Resolution shall become immediately effective upon the signature of the County Executive.

**SECTION 3.** It is found and determined that all formal actions of this Council relating to the adoption of this Resolution were adopted in an open meeting of the Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.


On a motion by Mr. Greenspan, seconded by Ms. Simon, the foregoing Resolution was duly adopted.
