## Resolution No. R2011-0179

Sponsored by: <b>County Executive FitzGerald/Department of Public Works/County Engineer</b>	<b>A Resolution</b> authorizing the County Executive to enter into a contract with Chemsteel Construction Company in the amount of \$1,163,153.00 for rehabilitation of Old Mill Road Bridge No. 162 over the Chagrin River in the Village of Gates Mills; authorizing the County Engineer, on behalf of the County Executive, to make an application for allocation from County Motor Vehicle \$5.00 License Tax Funds to fund said contract; and declaring the necessity that this Resolution become immediately effective.

WHEREAS, the Department of Public Works has recommended an award on RQ19651 to Chemsteel Construction Company for rehabilitation of Old Mill Road Bridge No. 162 over the Chagrin River in the Village of Gates Mills; and

WHEREAS, bids were received on April 12, 2011 and the engineer's estimate was \$1,800,000.00; and

WHEREAS, the Department of Public Works/County Engineer tabulated the extension of the unit bid prices submitted by each bidder and verified the accuracy of the total amounts and determined Chemsteel Construction Company to be the lowest and best qualified bidder; and

WHEREAS, funding for the project is as follows: Ohio Public Works Commission (Issue I) funds will provide 17%; the County will allocate 83% from the County Motor Vehicle \$5.00 License Tax Fund in accordance with Chapter 4504 of the Ohio Revised Code, in the amount of \$1,163,153.00.

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNTY COUNCIL OF CUYAHOGA COUNTY, OHIO:**

**SECTION 1.** That the recommended award on RQ19651 for the rehabilitation of Old Mill Road Bridge No. 162 over the Chagrin River in the Village of Gates Mills is approved and the County Executive is hereby authorized to enter into a contract with Chemsteel Construction Company in the amount of \$1,163,153.00.

**SECTION 2.** That the application for the allocation from the County Motor Vehicle \$5.00 License Tax Funds in the amount of \$1,163,153.00 is approved.

**SECTION 3.** It is necessary that this Resolution become immediately effective to assure that bridge work can commence and conclude during the prime construction

season. Otherwise, any delay in commencement of rehabilitation early on may cause work into the winter months and result in significant cost increases due to adverse weather conditions. Additionally, “Detour Limitations,” as per the plan, dictate an interim completion date of December 1, 2011, for the maintenance of two-way traffic or liquidated damages could be assessed. Provided that this Resolution receive the affirmative vote of eight members of Council, this Resolution shall become immediately effective upon the signature of the County Executive.

**SECTION 4.** It is found and determined that all formal actions of this Council relating to the adoption of this Resolution were adopted in an open meeting of the Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

On a motion by Ms. Conwell, seconded by Mr. Schron, the foregoing Resolution was duly adopted.
