## Resolution No. R2011-0181

Sponsored by: <b>County Executive FitzGerald/Department of Health and Human Services</b>	<b>A Resolution</b> authorizing the County Executive to enter into amendments to contracts with Care Coordination providers for family and youth involvement services for the Cuyahoga Tapestry System of Care for the period 1/1/2010 - 3/31/2011 to exercise an option to extend the time period to 3/31/2012 and for additional funds, and declaring the necessity that this Resolution become immediately effective.

WHEREAS, the Department of Health and Human Services has recommended amendments to contracts with Care Coordination providers for the Cuyahoga Tapestry System of Care (CTSOC) for the period 1/1/2010 – 3/31/2011 to exercise an option to extend the time period to 3/31/2012 and for additional funds; and,

WHEREAS, CTSOC’s primary service is wraparound, which involves a process of assembling a child and family team that collaboratively creates an individualized service plan (“Wraparound Plan”). These plans are driven by the perspective and needs of the child and family and incorporate an array of services, including both formal clinical services and neighborhood supports; and,

WHEREAS, the Care Coordination providers facilitate the wraparound process with a focus on meeting the mental health needs of the children enrolled with CTSOC; and,

WHEREAS, contract deliverables include, but are not limited to, providing neighborhood-based wraparound to children and families referred from Cuyahoga County Children and Family Services, Cuyahoga County Juvenile Court and the community. Contract deliverables also include a specialized mental health court docket and a domestic violence pilot program; and,

WHEREAS, the four Care Coordination contracts were procured through a Request for Proposal (RFP) process issued in 2009. The RFP (RQ14884) scope covers a three year period from 2010 through 2012 with contracts and amendments negotiated and issued annually based on the availability of funds; and,

WHEREAS, these contracts are to be funded with Health and Human Service levy dollars that are currently appropriated in the CTSOC budget; and,

WHEREAS, it is necessary that this Resolution become immediately effective in order that critical services provided by Cuyahoga County can continue, and to continue the usual and daily operation of the County.

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNTY COUNCIL OF CUYAHOGA COUNTY, OHIO:**

**SECTION 1.** The County Executive is hereby authorized to enter into contract amendments with various Care Coordination providers for the CTSOC for the period 1/1/2010 – 3/31/2011 to exercise an option to extend the time period to 3/31/2012 and for additional funds, as listed below:

- 1) Contract No. CE1000033-01 with Applewood Centers, Inc. in the amount of \$713,000.00.
- 2) Contract No. CE1000034-01 with Beech Brook in the amount of \$952,453.00.
- 3) Contract No. CE1000035-01 with Catholic Charities Services Corporation in the amount of \$773,485.00.
- 4) Contract No. CE1000037-01 with The Cleveland Christian Home Incorporated in the amount of \$797,403.17.

**SECTION 2.** It is necessary that this Resolution become immediately effective in order that critical services provided by Cuyahoga County can continue, and to continue the usual and daily operation of the County. Provided that this Resolution receives the affirmative vote of eight members of Council, this Resolution shall become immediately effective upon the signature of the County Executive.

**SECTION 3.** It is found and determined that all formal actions of this Council relating to the adoption of this Resolution were adopted in an open meeting of the Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
