Sponsored by: County Executive FitzGerald/Department of Health and Human Services and Councilmember Conwell	A Resolution authorizing the County Executive to enter into amendments to contracts with Care Coordination providers for family and youth involvement services for the Cuyahoga Tapestry System of Care for the period 1/1/2010 - 3/31/2011 to exercise an option to extend the time period to 3/31/2012 and for additional funds, and declaring the necessity that this Resolution become immediately effective.

WHEREAS, the Department of Health and Human Services has recommended amendment to contracts with providers for the Cuyahoga Tapestry System of Care (CTSOC) for family and youth involvement, advocacy and support services for the period 1/1/2010 – 3/31/2011 to exercise an option to extend the time period to 3/31/2012 and for additional funds; and,

WHEREAS, the Family/Youth Involvement contracts are critical to achieving a primary goal of CTOCS – family voice and choice; and,

WHEREAS, each Family/Youth Involvement contract is with a lead agency that serves as the fiscal and programmatic agent working with two to three other neighborhood-based agencies, all of which are also Neighborhood Collaboratives under the Family-to-Family model; and,

WHEREAS, contract deliverables include, but are not limited to, parent advocacy and support, youth involvement and development services, parent support resource activities and services, and community outreach, engagement, and resource development; and,

WHEREAS, the four Family/Youth Involvement contracts were procured through a Request for Proposal (RFP) process issued in 2009. The RFP (RQ14884) scope covers a three year period from 2010 through 2012 with contracts and amendments negotiated and issued annually based on the availability of funds; and,

WHEREAS, these contracts are to be funded with Health and Human Service levy dollars that are currently appropriated in the CTSOC budget; and,

WHEREAS, it is necessary that this Resolution become immediately effective in order that critical services provided by Cuyahoga County can continue, and to continue the usual and daily operation of the County.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNTY COUNCIL OF CUYAHOGA COUNTY, OHIO:

SECTION 1. The County Executive is hereby authorized to enter into contract amendments with various providers for the CTSOC for family and youth involvement, advocacy and support services for the period 1/1/2010 – 3/31/2011 to exercise an option to extend the time period to 3/31/2012 and for additional funds, as listed below:

- 1) Contract No. CE1000036-01 with Catholic Charities Community Services Corporation dba St. Martin de Porres Family Center in the amount of \$440,222.67.
- 2) Contract No. CE1000038-01 with The East End Neighborhood House Association in the amount of \$494,530.00.
- 3) Contract No. CE1000039-01 with University Settlement, Incorporated in the amount of \$454,095.00.
- 4) Contract No. CE1000040-01 with West Side Community House in the amount of \$532,556.00.

SECTION 2. It is necessary that this Resolution become immediately effective in order that critical services provided by Cuyahoga County can continue, and to continue the usual and daily operation of the County. Provided that this Resolution receives the affirmative vote of eight members of Council, this Resolution shall become immediately effective upon the signature of the County Executive.

SECTION 3. It is found and determined that all formal actions of this Council relating to the adoption of this Resolution were adopted in an open meeting of the Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
