WHEREAS, the Department of Health and Human Services, division of Family and Children First Council, has submitted a request for authorization to amend Agreement No. AG1000301-01 with Cleveland Public Library for administrative services for the MyCom Transitions Program for the period 1/1/2011 - 12/31/2011 to change the scope of services, effective 2/15/2011, and for additional funds in the amount of \$395,000.00; and

WHEREAS, the original contract amount was \$125,000.000 and this amendment will allow for the extension of the time period covered under the contract, and will further allow for the expansion of the scope of services offered based upon performance indicators showing that the number of families and youth participating in the services has increased; and

WHEREAS, the expansion of the scope of services will include Kindergarten Kits, Kindergarten Registration, and the "Youth Pages," which were previously provided under separate contract; and

WHEREAS, these services are extended to all Cuyahoga County families, and provide parents and children with programming, services and information that support healthy development and successful transitions from home/child care to kindergarten, 3rd to 4th grade, 8th to 9th grade, and into adulthood; and


NOW, THEREFORE, BE IT RESOLVED BY THE COUNTY COUNCIL OF CUYAHOGA COUNTY, OHIO:

SECTION 1. That the County Council hereby authorizes the County Executive to amend Agreement No. AG1000301-01 with Cleveland Public Library for administrative services for the MyCom Transitions Program for the period 1/1/2011 - 12/31/2011 to change the scope of services, effective 2/15/2011, and for additional funds in the amount of \$395,000.00.

SECTION 2. It is found and determined that all formal actions of this Council relating to the adoption of this Resolution were adopted in an open meeting of the Council, and that all deliberations of this Council and of any of its committees that

resulted in such formal action were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
