WHEREAS, the County Executive/Department of Information Technology has recommended awards on RQ40947 to various providers, in the total amount not-to-exceed \$4,542,350.00, for IT hardware, software and other peripheral items for the period 12/1/2017 - 11/30/2020 as follows:

1. Logicalis, Inc.
2. TEC Communications, Inc.
3. Rolta Advizex Technologies, LLC
4. Telestream, LLC; and
5. MNJ Technologies Direct, Inc.

WHEREAS, the primary goal of this project is to establish a price list to purchase IT Hardware, Software and other Peripheral items which will allow the County to replace legacy infrastructure and introduce new technologies to infuse performance efficiencies in our infrastructure environment, including but not limited to, voice, wireless, storage, virtual and backup environments; and

WHEREAS, this project is funded as follows: (a) \$3,742,350.00 from General Fund and (b) \$800,000.00 from the HHS Levy/Federal Funds; and

WHEREAS, it is necessary that this Resolution become immediately effective in order that critical services provided by Cuyahoga County can continue and to provide for the usual, daily operation of a County entity.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNTY COUNCIL OF CUYAHOGA COUNTY, OHIO:

SECTION 1. That the Cuyahoga County Council hereby makes awards on RQ40947 to various providers, in the total amount not-to-exceed \$4,542,350.00, for IT hardware, software and other peripheral items for the period 12/1/2017 - 11/30/2020 as follows:

1. Logicalis, Inc.
2. TEC Communications, Inc.
3. Rolta Advizex Technologies, LLC
4. Telestream, LLC; and
5. MNJ Technologies Direct, Inc.

SECTION 2. That the County Executive is authorized to execute a master contract in connection with said awards and all other documents consistent with this Resolution.

SECTION 3. It is necessary that this Resolution become immediately effective for the usual daily operation of the County; the preservation of public peace, health or safety in the County; and any additional reasons set forth in the preamble. Provided that this Resolution receives the affirmative vote of at least eight members of Council, it shall take effect and be in force immediately upon the earliest occurrence of any of the following: (1) its approval by the County Executive through signature, (2) the expiration of the time during which it may be disapproved by the County Executive under Section 3.10(6) of the Cuyahoga County Charter, or (3) its passage by at least eight members of Council after disapproval pursuant to Section 3.10(7) of the Cuyahoga County Charter. Otherwise, it shall take effect and be in force from and after the earliest period allowed by law.

SECTION 4. It is found and determined that all formal actions of this Council relating to the adoption of this Resolution were adopted in an open meeting of the Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

On a motion by Mr. Miller, seconded by Mr. Schron, the foregoing Resolution was duly adopted.
