WHEREAS, the County Executive/Department of Public Safety and Justice Services/Division of Witness/Victim has recommended an award on RQ42537 to Mental Health Services for Homeless Persons, Inc. dba FrontLine Service in the amount not-to-exceed \$898,300.00 for operation of the Children Who Witness Violence Program for the period 1/1/2019 - 12/31/2021; and

WHEREAS, the primary goal of this project is to utilize a qualified behavioral health agency capable of providing services to children and their families who witness violence, as identified and referred by law enforcement agencies; and

WHEREAS, this project is funded 100% Health and Human Services Levy funds; and

WHEREAS, it is necessary that this Resolution become immediately effective in order that critical services provided by Cuyahoga County can continue and to provide for the usual, daily operation of a County entity.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNTY COUNCIL OF CUYAHOGA COUNTY, OHIO:

SECTION 1. That the Cuyahoga County Council hereby makes an award on RQ42537 to Mental Health Services for Homeless Persons, Inc. dba FrontLine Service in the amount not-to-exceed \$898,300.00 for operation of the Children Who Witness Violence Program for the period 1/1/2019 - 12/31/2021.

SECTION 2. That the County Executive is authorized to execute the contract in connection with said award and all other documents consistent with this Resolution.

SECTION 3. It is necessary that this Resolution become immediately effective for the usual daily operation of the County and the reasons set forth in the preamble. Provided that this Resolution receives the affirmative vote of at least eight members of Council, it shall take effect and be in force immediately upon the earliest occurrence of any of the following: (1) its approval by the County Executive through signature, (2) the expiration of the time during which it may be disapproved by the County Executive under Section 3.10(6) of the Cuyahoga County Charter, or (3) its passage by at least eight members of Council after disapproval pursuant to Section 3.10(7) of the Cuyahoga County Charter. Otherwise, it shall take effect and be in force from and after the earliest period allowed by law.

SECTION 4. It is found and determined that all formal actions of this Council relating to the adoption of this Resolution were adopted in an open meeting of the Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Summary of Deviation

Existing criteria / language in Approval Resolution:

R2018-0205 was approved by County Council on 11/13/2018 with an incorrect contract end date listed on the item agenda. The executed resolution reads *‘A resolution making an award on RQ42537 to Mental Health Services for Homeless Persons, Inc. dba Frontline Service in the amount of \$898,300.00 for operation of the Children Who Witness Violence Program for the Period 1/1/2019-12/31/2021;’*. The correct end date of the awarded contract is 12/31/2020.

Deviation:

We are requesting a deviation to the approved resolution to correct the end date of the contract to match the executed award dates of 1/1/2019-12/31/2020. The Council agenda had the incorrect end date listed and the Department did not catch during the Council readings and approval. Therefore, the resolution lists the incorrect end date as well as the contract cover. We are requesting the deviation so the Council Resolution and vendor contract cover can be corrected to negate any confusion over the award dates.

Law Department’s Analysis of Deviation:

Given that the corrected term of the contract is within the term Council approved, the Law Department can approve the deviation of the end date as authorized by County Code Section 501.06.
