<p>Sponsored by: County Executive Ronayne/Fiscal Officer/Office of Budget and Management</p>	<p>A Resolution amending the 2022/2023 Biennial Operating Budget for 2023 by providing for additional fiscal appropriations from the General Fund and other funding sources, for appropriation transfers between budget accounts and for cash transfers between budgetary funds, to meet the budgetary needs of various County departments, offices and agencies, amending Resolution No. R2023-0021 dated 1/24/2023, Resolution No. R2023-0028 dated 2/14/2023 and Resolution No. R2023-0052 dated 3/14/2023; and declaring the necessity that this Resolution become immediately effective.</p>

WHEREAS, on December 7, 2021, the Cuyahoga County Council adopted the Biennial Operating Budget and Capital Improvements Program for 2022/2023 (Resolution No. R2021-0238) establishing the 2022/2023 biennial budget for all County departments, offices and agencies; and

WHEREAS, it is necessary to adjust the Biennial Operating Budget for 2023 to reflect budgetary funding increases, funding reductions, to transfer budget appropriations and to transfer cash between budgetary funds, to accommodate the operational needs of certain County departments, offices and agencies; and

WHEREAS, it is further necessary that this Resolution become immediately effective in order that critical services provided by Cuyahoga County can continue and to provide for the usual, daily operation of County departments, offices, and agencies.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNTY COUNCIL OF CUYAHOGA COUNTY, OHIO:

SECTION 1. That the 2022/2023 Biennial Operating Budget for 2023 be amended to provide for the following additional appropriation increases and decreases:

The Department of Public Safety & Justice Services requests an appropriation increase of \$189,357 for a contract relating to the OPIOID Awareness and Prevention Campaign. The funding source is the Opioid Fund which has a current cash balance of \$82,064,315.

The Sheriff’s Department requests an appropriation decrease of \$43,205.66 to close out the FY 2012 Community Oriented Policing Services grant. The original grant award was \$1,603,160 and had an original cash match of \$603,160. Of the original award \$1,536,443.21 or 96% was spent. The performance period was June 1, 2012, through May 31, 2015 with a funding source of the U.S. Department of Justice. There is a current cash balance of \$23,511.13 which is also on this agenda (section 3 item A - CT2319668) to be resolved via cash transfer back to its original source.

The original grant award was \$200,000 and \$187,510.70 or 94% of the funds were spent. The performance period was September 1, 2017, through July 31, 2022

and the funding source is the Federal Emergency Management Agency (FEMA). There was no cash match requirement for this grant.

The performance period was September 1, 2016 through May 30, 2019 with a funding source of the Federal Emergency Management Agency (FEMA) passed through the Ohio Emergency Management Agency. There was no cash match requirement for this grant.

This item was approved via BOC2022-763. The performance period is October 1, 2022 through September 30, 2026 and has a funding source of the US Department of Justice, Office of Justice Programs, Bureau of Justice Assistance. There is a \$233,334 or 25% cash match requirement which will be funded by the ODRC TCAP.

The Office of Budget and Management, on behalf of the Prosecutor’s Office, requests an appropriation transfer of \$1,438,749.61 from other expenses to personal services. SECTION 5. The Fiscal Department is authorized to disburse pro-rated monthly subsidy payments to The MetroHealth System from the Health and Human Services Levy Fund through June 2023. Subsequent subsidy payments for Fiscal Year 2023 shall be contingent upon approval by Council.

SECTION 6. It is necessary that this Resolution become immediately effective for the usual daily operation of the County; the preservation of public peace, health, or safety in the County; and any additional reasons set forth in the preamble. Provided that this Resolution receives the affirmative vote of at least eight members of Council, it shall take effect and be in force immediately upon the earliest occurrence of any of the following: (1) its approval by the County Executive through signature, (2) the expiration of the time during which it may be disapproved by the County Executive under Section 3.10(6) of the Cuyahoga County Charter, or (3) its passage by at least eight members of Council after disapproval pursuant to Section 3.10(7) of the Cuyahoga County Charter. Otherwise, it shall take effect and be in force from and after the earliest period allowed by law.

SECTION 7. It is found and determined that all formal actions of this Council relating to the adoption of this Resolution were adopted in an open meeting of the Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
