Sponsored by: County Executive Ronayne/Fiscal Officer/Office of Budget and Management	A Resolution amending the 2022/2023 Biennial Operating Budget for 2023 by providing for additional fiscal appropriations from the General Fund and other funding sources, for appropriation transfers between budget accounts and for cash transfers between budgetary funds, to meet the budgetary needs of various County departments, offices and agencies; and declaring the necessity that this Resolution become immediately effective.

WHEREAS, on December 7, 2021, the Cuyahoga County Council adopted the Biennial Operating Budget and Capital Improvements Program for 2022/2023 (Resolution No. R2021-0238) establishing the 2022/2023 biennial budget for all County departments, offices and agencies; and

WHEREAS, it is necessary to adjust the Biennial Operating Budget for 2023 to reflect budgetary funding increases, funding reductions, to transfer budget appropriations and to transfer cash between budgetary funds, to accommodate the operational needs of certain County departments, offices and agencies; and

WHEREAS, it is further necessary that this Resolution become immediately effective in order that critical services provided by Cuyahoga County can continue and to provide for the usual, daily operation of County departments, offices, and agencies.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNTY COUNCIL OF CUYAHOGA COUNTY, OHIO:

SECTION 1. That the 2022/2023 Biennial Operating Budget for 2023 be amended to provide for the following additional appropriation increases and decreases:

Probate Court requests an appropriation increase of \$10,000 to cover costs for judicial staff to attend mandatory seminars and conferences this year. Pursuant to Ohio Revised Code revenue is generated from the filing fees collected on the estate, guardianship and adversarial cases that are filed with the Clerk of Court. The funding source is the Conduct of Business Fund. The current cash balance as of 3/31/2023 is \$53,565.

Probate Court requests an appropriation increase of \$5,000 for additional mediation services. Probate Court anticipates the volume of mediation will increase this year due to the elimination of COVID restrictions. Pursuant to Ohio Revised Code revenue is generated from the filing fees collected on estate, guardianship and adversarial cases that are filed with the Clerk of Court. The funding source is the Dispute Resolution Fund. The current cash balance as of 3/31/2023 is \$1,042,242.

The Department of Health and Human Services - Division of Children and Family Services requests appropriation of \$1,436,238.16 for Workforce Funding Supports Initiative. Funds will be used to provide support to agency culture and climate initiatives, transportation services, and other local strategies to support caseworker recruitment and retention. The grant period is from June 14, 2022 through June 30, 2023. BOC approval was received via CON2023-18. The funding source is the Public Children Services Association of Ohio. There is no required cash match.

The Department of Public Safety & Justice Services requests an appropriation increase of \$20,595.25 to establish the FY22 Stop Violence Against Women Act Grant. This grant will reimburse the County for a portion of personnel costs associated with administering the VAWA Block FY22 program. BOC approval was received via BC2023-172. The funding source is the Ohio Department of Public Safety, and has a performance period of January 1, 2023, through March 31, 2024. The cash match requirement is 25% or \$5,148.81. There is a corresponding cash match request on this agenda (Section 3 Item B, CT2319687).

The funding source is the General Fund but this item and Item K are both budget neutral.

The Department of Public Safety & Justice Services requests a cash transfer of \$5,148.81 to fulfill the cash match requirement of the FY22 Stop Violence Against Women Act Grant. The funding source is the Ohio Department of Public Safety, and has a performance period of January 1, 2023, through March 31, 2024.

SECTION 4. The Fiscal Department is authorized to disburse pro-rated monthly subsidy payments to The MetroHealth System from the Health and Human Services Levy Fund through June 2023. Subsequent subsidy payments for Fiscal Year 2023 shall be contingent upon approval by Council.

SECTION 5. It is necessary that this Resolution become immediately effective for the usual daily operation of the County; the preservation of public peace, health, or safety in the County; and any additional reasons set forth in the preamble. Provided that this Resolution receives the affirmative vote of at least eight members of Council, it shall take effect and be in force immediately upon the earliest occurrence of any of the following: (1) its approval by the County Executive through signature, (2) the expiration of the time during which it may be disapproved by the County Executive under Section 3.10(6) of the Cuyahoga County Charter, or (3) its passage by at least eight members of Council after disapproval pursuant to Section 3.10(7) of the Cuyahoga County Charter. Otherwise, it shall take effect and be in force from and after the earliest period allowed by law.

SECTION 6. It is found and determined that all formal actions of this Council relating to the adoption of this Resolution were adopted in an open meeting of the Council, and that all deliberations of this Council and of any of its

committees that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
