## Resolution No. R2023-0145

Greiner as Interim Sheriff to July 31, 2023; and declaring the necessity that this Resolution become immediately effective.</p>

**WHEREAS**, pursuant to Article II, Section 2.03(2) of the Charter of Cuyahoga County, the County Executive may appoint interim officers to serve as a departmental director without confirmation by the Council for a period not to exceed 120 days and an interim appointment may continue beyond 120 days only if confirmed by the Council prior to the expiration of the initial interim appointment; and

**WHEREAS**, the initial term of Joseph S. Greiner as Interim Sheriff is set to expire on June 17, 2023; and

**WHEREAS**, the County Executive has recommended extending the term of Joseph S. Greiner's appointment as Interim Sheriff to July, 31, 2023; and

**WHEREAS**, it is necessary that this Resolution become immediately effective in order that Charter requirements can be complied with and critical services provided by Cuyahoga County can continue, and to provide for the usual, daily operation of County government.

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNTY COUNCIL OF CUYAHOGA COUNTY, OHIO:**

**SECTION 1.** That the Cuyahoga County Council hereby confirms the extension of the term of Joseph S. Greiner as Interim Sheriff to July 31, 2023, or until a permanent appointment is made, whichever is sooner.

**SECTION 2.** It is necessary that this Resolution become immediately effective for the usual daily operation of the County; the preservation of public peace, health, or safety in the County; and any additional reasons set forth in the preamble. Provided that this Resolution receives the affirmative vote of eight members of Council, this Resolution shall become immediately effective.

**SECTION 3.** It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of the Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

On a motion by Ms. Simon, seconded by Ms. Turner, the foregoing Resolution was duly adopted.
